Fully Vaccinated People are Coming Down With COVID-19

The fact is that there are plenty of cases of people who have been fully vaccinated for COVID-19 and still got infected with the SARS-CoV-2 virus.

Take the recent case of the **nine fully vaccinated New York Yankees players and staff members** who tested positive for COVID-19. Seven of them were asymptomatic and two showed mild symptoms.

Or how about **comedian and television host Bill Maher, who recently tested positive for COVID-19 despite being fully vaccinated?** He also was **asymptomatic**.

Vaxxed Facts

The FDA document, dated May 19, 2021, is titled: “FDA In Brief: FDA Advises Against Use of SARS-CoV-2 Antibody Test Results to Evaluate Immunity or Protection From COVID-19, Including After Vaccination”

The FDA is saying, “Look, the vaccine creates specific antibodies against the spike protein, not the virus. If you take the standard antibody test after vaccination, it’ll be useless, because the test isn’t meant to detect antibodies against the spike protein. It only detects antibodies against the virus.”

Since developing antibody tests is as easy as pie, why hasn’t the FDA developed one that detects antibodies against the spike protein?

And the answer to that question is obvious. If the FDA did develop such a test, then—in terms of conventional vaccine theory—it would be easy to see how well the vaccine is working, or not working.

And THAT is not a goal public health officials want to achieve. That is not a risk worth taking. Suppose, after testing 20,000 vaccinated people, it turns out that only 800 have produced antibodies against the spike protein?

Another (unanswered) question: Are specific antibodies against the spike protein, conferred by the vaccine, sufficient to neutralize, disable, destroy the actual virus if it drops down out of a cloud and tries to infect a vaccinated person?

'Ignore the CDC': Top doc says we've reached herd immunity

Arguing for people who choose not to be vaccinated, a Johns Hopkins professor estimates that nearly half the country has natural immunity due to prior infection that protects them from COVID-19.

Dr. Marty Makary, in an interview Tuesday with "The Vince Coglianesi Show" on WMAL in Washington, claimed **the United States already has achieved the objective of herd immunity**, combining the vaccinated with those who have been infected. **He estimates 85% of the population is immune to the novel coronavirus.**

"Please, ignore the CDC guidance," he said, calling it the slowest "most reactionary CDC in history."

The FDA cover-up that led to the approval of the Pfizer vaccine

BY THEIR OWN STANDARDS, the **FDA should never have allowed the Pfizer COVID vaccine to be shot into a single arm.** The Agency's Emergency Use Authorization was a crime—according to their own data.

The document, posted on the FDA website, is titled, "Vaccines and Related Biological Products; Advisory Committee Meeting; FDA Briefing Document Pfizer-BioNTech COVID-19 Vaccine." It is dated December 10, 2020. The date tells us that all the information in the document is taken from the Pfizer clinical trial, based on which the FDA authorized the vaccine for public use.

A key quote is buried on page 42: "Among 3410 total cases of suspected but unconfirmed COVID-19 in the overall study population, 1594 occurred in the vaccine group vs. 1816 in the placebo group [who received a saltwater shot]."

Those shocking numbers have never seen the light of day in news media.

The comparative numbers reveal that the vaccine was not effective at preventing COVID-19. It was certainly not 50% more effective than no vaccine at all—the standard for FDA Emergency Use Authorization.

The researchers assumed the SARS-CoV-2 virus was spreading everywhere in the world, and during the clinical trial, it would descend on some volunteers.

The billion-dollar question was: how many people receiving the vaccine would become infected, vs. how many people in the placebo group? If it turned out that FAR FEWER people getting the vaccine became infected with SARS-CoV-2, the vaccine would be hailed as a success. It protected people against the virus.

But as you can see from the numbers above, that wasn't the case at all. So now we come to the vital weasel-phrase in the FDA document I just quoted: "suspected but unconfirmed COVID-19 [cases]."

"Well, you see, we can't say these were ACTUAL COVID-19 cases. Maybe they were, maybe they weren't. They're in limbo. We want to keep them in limbo. Otherwise, our clinical trial is dead in the water, and we'll never get approval for the vaccine."

What does "suspected cases" mean? It can only mean these people all displayed symptoms consistent with the definition of COVID-19, but they're unconfirmed cases because...their PCR tests were negative, not positive. However, if their tests were negative, why would they be called "suspected cases" instead of "NOT CASES"?

Something is wrong here. The FDA is hedging its bets, muddying the waters, obscuring facts.

By FDA/CDC rules, a case of COVID-19 means: a person has tested positive, period. That's the way cases are counted.

WHAT SHOULD WE DO?

First of all, do not take their poisonous jab! The spike protein is the poison!

Just in case you did not know, and you took the jab, you should expect damage and even face death in the next two years if you do nothing.

Start by purchasing, or go outside and find **white pine needles**/leaves (white pine, fir, cedar, and spruce needles contain shikimic acid and suramin), and make an infusion in **hot water (steep 30 minutes) with some alcohol or fat such as coconut oil or butter.**

Use a lot of leaves per litre of water, and let them infuse for about ½ hour.

Better to use an electric blender to extract the **shikimic acid and the suramin**. Then put the whole in a strainer and press the paste with a spoon to extract the juice. Drink ½ a glass of this extract morning and evening for neutralizing the spike proteins.

Take one tablet of Hydroxychloroquin every three weeks. This quells the cytokine storm triggered off by the spike protein. On alternate weeks take Iver-Mectin one cc per 100 pounds to boost the immune system. Also take zinc orotate to prevent replication of any viruses.

For the **prevention of blood clogs, you must take one tablespoon of natto (fresh or dehydrated) each eight hours. It is important that you take whole natto, not the purified nattokinase; this enzyme dissolves the clogs. Beside nattokinase, natto contains also other important molecules, one of them being vitamin K2, important for the health of vasculature walls damaged by the spike protein. Also Zymessence, a systemic enzyme will dissolve clots.**

By doing this, little by little, your body is going to get rid of the cells producing the spike protein, and then you may consider yourself safe.

Keep in mind that **vaccinated people seem to shed the spike protein around them.** So, if you live in presence of such people, at home or at work, you must protect yourself against the shedding with natto, **vitamin D3 (10000 U.I./DAY), magnesium, zinc, vitamin C, vitamin A and glutathione.**

Eat healthy food, expose yourself to sunshine and if possible, deep yourself into seawater regularly, and most important do not forget your white pine needles drink.

This was a multi-trillion dollar mistake!

COVID-19 is caused by Graphene Oxide introduced by several ways into the body
